छत्तीसगढ़ विश्वविद्यालय (संशोधन) अधिनियम, 2015 दिनांक 24 अप्रैल 2015 के भाग – 04 के अन्तर्गत समस्त परिनियम, अध्यादेश तथा विनियम का क्रियान्वयन पं. रविशंकर शुक्ल विश्वविद्यालय, रायपुर के अनुसार ही दुर्ग विश्वविद्यालय, दुर्ग में प्रवृत्त होना वर्णित है। तदनुसार पं. रविशंकर शुक्ल विश्वविद्यालय, रायपुर की अधिसूचना क्र. 12548/अका./13, रायपुर दिनांक 11.11.2013 के अंतर्गत विश्वविद्यालय विद्या परिषद की स्थायी समिति की बैठक दिनांक 20.09.2013 में अनुमोदित विनियम 150 निम्नांकित है जो दुर्ग विश्वविद्यालय, दुर्ग में भी प्रवृत्त होंगे:-

Regulation No. 150

(As per Ministry of Social Justice & Empowerment, Department of Disability Affairs, GOI, Office letter No. F.No.16-110/2003-DD. III New Delhi. Dated 26-02-2013 u/s 6(20) of the University Act)

- Objective** : The objective of this regulation is to provide facility to the differently-abled examinees during examination conducted by Durg University, Durg.
- Scope** : The scope of this regulation shall be limited to the examinees appearing in any examination conducted by the University.
- Definition of differently-abled examinee** : Differently-abled examinee means here after the examinee that is differently-abled due to disability of 40% or more duly certified by the competent authority.
- Assistance to differently-abled examinee** : The facility of scribe/reader/lab assistant should be allowed to any examinee during the examination conducted by the University who is differently-abled a per definition given in para 3 above. In the case of emergency, also the examinee can change the assistant subject to sufficient reason and permitted by the Examination Superintendent.
- Discretion of assistance** : The examinee shall have the discretion of opting for his own scribe/reader/lab assistant at the university examination duly permitted by the examination Superintendent of that examination.
- Restriction on assistance** : There shall be no restriction upon differently-abled examinee to choose assistant with respect to educational qualification, marks scored, or age. However, there shall be strict binding upon him/her or his/her assistant not to indulge in malpractices like copying and cheating during the examination.
- Option of Examination Mode** : Differently-abled examinee shall be given option of choosing the mode for taking the examinations i.e. in Braille or in the computer or in large print or even by recording the answers as the examination bodies can easily make use of technology to convert question paper in large prints, e-text, or Braille and can also convert Braille text in English or regional languages.
- Computer use** : Where ever use of the computer is needed, the examinee should be allowed to check the computer system one day in advance so that the problems, if any in the software/system could be rectified.


9. **Examination form** : In any case, examinee shall be require to mention at the time of filling the examination form with necessary detail regarding the mode of availing the scribe so that it is duly recorded for the purpose of examination.
10. **Seating arrangement** : The Centre Superintendent of the examination shall ensure the availability of question papers in the format opted by the candidate as well as suitable seating arrangement preferably at the ground floor for giving examination.
11. **Compensatory time** : The word “extra time or additional time” should be known as “compensatory time” and the same should not be less than 20 minutes per hour of examination for examinee who is making use of scribe/reader/lab assistant. The differently-abled examinee not availing the facility of scribe may be allowed additional time of minimum of one hour for examination of 3 hours duration.
12. **Assistance device** : The differently-abled examinee should be allowed to use assistive devices like calculator (in cases where calculators are allowed for giving exams), tailor frame, Braille slate, abacus, geometry kit, Braille measuring tape and augmentative communication devices like communication chart and electronic devices.
