Applications are invited for the appointment on the post of Vice-Chancellor (Kulapati), Hemchand Yadav Vishwavidyalaya, Durg (C.G.) under the Chhattisgarh Vishwavidyalaya Adhiniyam, 1973 and Amendment Act, 2010.

Applications are invited from person satisfying requirements as laid down in para 7.3 of the University Grants Commission Regulations, 2018 dated 18th July, 2018. The Vice-Chancellor (Kulapati), being the academic as well as administrative head, is expected to be:-

- A visionary with proven leadership qualities, administrative capabilities as well as teaching and research credentials.
- He/ She should be a distinguished academician, with a minimum of ten years of experience as Professor in a University or ten years of experience in a reputed research and /or academic administrative organization with proof of having demonstrated academic leadership as per "UGC Regulations on Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education 2018" and subsequent modifications.
- The maximum tenure for the post of Vice-Chancellor (Kulapati) is 5 (Five) years, or up to the age of 70 (Seventy) years, whichever is earlier and shall not be eligible for appointment for more than two terms.

Aspirants for the post of Vice-Chancellor (Kulapati) may send their applications along with their documents **in three sets** :-

1. Application in the prescribed format, with recent passport size colour photograph.
2. All pages of the filled applications must be signed.
3. Attach self attested copies of certificates/relevant documents in support of experience as per eligibility criteria and educational qualifications.

Aspirants for the post of Vice-Chancellor (Kulapati) may send their applications to the "**Secretary to Governor, Raj Bhavan, Raipur (C.G.)- 492 001**", so as to be received on or before **4th October, 2024**, by the Registered Post/Speed Post.
